



This is Annexure 1 of 1 page referred to in section 5 of Form 603 Notice of initial substantial holder for Kingsland Minerals Ltd dated 14 March 2023.

Reference is made to section 6.2 of the Kingsland Minerals Ltd Prospectus dated 12 April 2022, on 8 July 2021, Kingsland Minerals Ltd (Company) entered into a binding option agreement with Bacchus Resources Pty Ltd (Bacchus) as amended by letter deeds of variation dated 23 November 2021, 14 March 2022 and 6 April 2022, pursuant to which Bacchus had agreed to grant the Company the option to acquire five exploration licences (EL 31457, EL 31409, EL32275, EL31659 and EL 31764) in the Northern Territory (Bacchus Option) (Bacchus Agreement).

Pursuant to the Bacchus Agreement, the Bacchus Option was exercised by the Company during the option period. As consideration for the grant of the Bacchus Option, the Company had agreed to issue to Bacchus on completion of the Bacchus Agreement 3,081,081 ordinary fully paid shares.
