This is Annexure 1 of 1 page referred to in section 5 of Form 603 Notice of initial substantial holder for Kingsland Minerals Ltd dated 22 June 2022.

With reference to section 6.1 of the Kingsland Minerals Ltd Prospectus dated 12 April 2022, on 8 July 2021, Kingsland Minerals Ltd (Company) entered into a binding option agreement with Trafalgar Resources Pty Ltd (Trafalgar) as amended by letter deeds of variation dated 9 March 2022 and 6 April 2022, pursuant to which Trafalgar had agreed to grant the Company the option to acquire three exploration licences (EL 31960, EL 32152 and EL 32418) in the Northern Territory (Trafalgar Option) (Trafalgar Agreement).

Pursuant to the Trafalgar Agreement, the Trafalgar Option was exercised by the Company during the option period. As consideration for the grant of the Trafalgar Option, the Company had agreed to issue to Trafalgar on completion of the Trafalgar Agreement 2,055,405 ordinary fully paid shares.
